

Andrews Federal Credit Union 2010 Scholarship Contest

In an effort to promote the importance of financial literacy, Andrews Federal awards scholarships to student members as a service to the community annually. We encourage you to participate in this opportunity to receive **one** of eight \$1,500 non-renewable scholarships for higher education and books.

Any Andrews Federal member or member's dependent pursuing a degree from an accredited college or university is eligible to apply.

Application Process

Applications are available online and in branches from January 4 through April 16, 2010. All applicants must be 16 years of age or older and be a member or member's dependent with an Andrews Federal account in good standing by **January 1, 2010**. (If student is a member's dependent, student does not have to have an account; parent/guardian can be the account-holder).

Completed scholarship applications must be received at: Andrews Federal Credit Union, 5711 Allentown Rd., Suitland, Maryland 20746 by **April 16, 2010**.

Applications will be judged by a panel on the following: essay, community service, and recommendations. Scholarships will be awarded to the eight applicants receiving the highest scores overall. Winners will be notified by mail on or around May 14, 2010. Scholarship recipients will be officially announced in the Andrews Federal newsletter and website in June 2010.

Application Packet

The 2010 scholarship application is available in our branches or online. Judges will not know the identities of applicants during the process. Please remember to complete and return the information below as part of your application.

1. **Essay:** In 500 words or less, please discuss the following:

What is/are the best way(s) that Andrews Federal can impact and inform today's youth about the importance of financial literacy?

2. **Recommendations:** Present two letters of recommendation from a teacher, college professor, counselor *or* employer. Letters cannot be written by relatives.
3. **Community Service:** Outline your community service involvement within the past two years.
4. **Acceptance Letter:** Include your letter of acceptance or proof of enrollment from an accredited college or university.
